The system for distributing garbage collection schedules, etc., is changing

Until now, copies of the Japanese version of the garbage collection schedule and guidelines for how to throw out garbage have been distributed to each household in the city. This year, though, there are no major changes to garbage separation rules, so calendars will not be distributed. Please use the schedule you received last year. Foreign-language copies of the schedule and guidelines will be available as normal from the Communication Corner, from the Citizens' Affairs Division on the first floor in the City Office, or from the Waste Management Division on the second floor in the City Office. When moving house, please dispose of garbage as early as possible! •

引越しゴミの処理は お早めに!

You can dispose of household garbage free of charge at the garbage processing centers. These garbage processing centers will be busier than normal from the middle of March, because of the large numbers of people disposing of garbage as they move house. In order to minimize the crowding, please take any garbage to the processing centers as early as possible, and during the busy period please avoid as much as possible disposing garbage not related to moving house. Please also be aware that only those disposing of their own garbage, or permitted contractors, are allowed to transport garbage to the garbage processing centers. For details of these contractors, please contact the Waste Management Division (Haikibutsu-taisaku-ka, 廃棄物対策課).

The Citizens' Affairs Division will be open for a range of services between 8:30 and 12:30, on Sunday March 9th, Sunday March 23rd, Sunday March 30th, Sunday April 6th, Sunday Aril 13th, and Sunday April 27th. In addition, there are extended service hours at the Citizens' Affairs Division on Thursdays (holidays and the year-end period excepted). Thursday extended service hours are until 19:00.

Only certain services are available on the Sundays above, and during extended service hours on Thursdays, and some paperwork may require that another office is contacted, in which case the formalities may not be able to be completed immediately. Services available include the following:

- Change of residence (moving into, out of, or within Higashihiroshima City)
- Registration of personal seals (inkan)
- Issuance of Citizen's Identification Cards (Personal Seal Registration Cards)
- Issuance of various certificates (tax payment, seal registration, etc.)

Please make sure that you take official identification with you (photo identification, such as a driving license, Residence Card, etc.).

Be sure to complete formalities for light vehicles and motorcycles before the end of March! ・ 軽自動車税の廃車手続きは お済みですか?

Light Vehicle and Motorcycle Tax (keijidosha-zei, 軽自動車税) is levied on persons who are the owners of a light vehicle (a car of 660cc or below) or a motorcycle) as of April 1st each year. If you are planning to sell or dispose of your light vehicle or motorcycle, please ensure that the necessary formalities are completed by the end of March. If the formalities are not completed by the end of March, then you will be subject to tax even if you sell or dispose of your vehicle after April 1st.

School Expenses Subsidies System, 2014-15 Academic Year

Higashihiroshima City provides financial subsidies covering a part of the costs of school supplies, school lunches, etc., for families who have children in municipal elementary schools and/or junior high schools in the city. The subsidies are available to families where financial support is judged to be necessary.

1 Who can apply to receive financial support?

Parents who live in Higashihiroshima City, who have the child for whom the financial support will be provided enrolled in a municipal elementary or junior high school within the city, and to whom at least one of the following conditions is applicable.

If applying under reason 8, your application will be judged on the income of the members of the same household, based on the criteria for welfare payments.

%1 If the reason for application is 2, 3 or 8, and you moved to Higashihiroshima City on or after January 2nd, 2014, it will be necessary to submit a 'Certificate of Exemption from Municipal Tax' issued by the city, town or village you were living in as of January 1st, 2014.

X2 Depending on the circumstances of your household, it may be necessary to submit other documents, as specified by Higashihiroshima City Board of Education.

2 How to apply

■ If you wish to apply to receive financial support, please obtain an 'Application Form for School Expenses Subsidies' from your child's school, fill in the necessary information, and submit it to the school, along with any other necessary documents, depending on the reason for your application. If you do not have the necessary documents immediately available, please submit the application form first, and then provide the necessary documents later.

If you have more than one child, and the children attend different schools, please apply to each school separately.

It is necessary to reapply even if you were receiving financial support during the previous academic/financial year.

■ Applications can be accepted at any time during the year. However, as a rule, for applications made in months other than April, the subsidies will begin to be paid from the month after the application was made.

All payments are made through the child's school.

Subsidies for school supplies are paid in two installments, one for each semester of the school year. If an application for financial support is approved part-way through the semester, subsidies will be paid based on the remaining number of months. However, if you are receiving similar support from another city, town or village, it is not possible to receive double payments.

Subsidies for school supplies for starting school will only be paid to parents of children who are in the first grade, where the application has been approved during April.

For households receiving welfare payments, only the costs of school trips and medical costs will be paid.

If you move out of Higashihiroshima City mid-way through a school semester, or if the reason for your application for support becomes no longer applicable, you may be required to pay back all or part of the subsidies that have been paid to you.
