①Registration of birth and resident registration: Please complete the procedure by Tuesday, September 16. September 14th, the 14th day including the date of birth, is Sunday, and the next day, September 15th is a national holiday, so the next opening day is the 16th of the next day of the notification period. (Even if you were born on Tuesday September 2 or Wednesday September 3, Tuesday September 16 is the final day of the period for the registration of birth.)

②Child allowance: Please complete the procedure by Tuesday, September 16.

③Medical expenses payments scheme for infants and toddlers: Please complete the procedure by Friday, September 12.

(4) Application for permission to obtain status of residence: Please complete the procedure by Tuesday, September 30.
