# Emergency Support Payments for the 2023-24 Financial Year

(令和5年度経済対策緊急支援給付金のご案内)

In the case of households that have been affected by the recent rise in prices, emergency support payments will be made to the heads of households exempt from resident tax for the 2023-24 financial year.

### Payment amount

# 70,000 yen per household

### Eligibility and whether application is necessary

#### Eligible households

Households in which all members are **exempt from resident tax** for the 2023-24 financial year

Please use the enclosed reply envelope.

Deadline for submission:  
**Friday March 15th, 2024.**

**Valid if postmarked on this date.**

# Formalities to Receive the Payment

## 1: Conditions for payment

• All members of the household on the Basic Resident Register as of December 1<sup>st</sup>, 2023 must be exempt from Residence Tax for the 2023-24 financial year. However, if all members of the household are dependent on a family member, etc., who is subject to Residence Tax, the household is ineligible.

(Examples of ineligibility)

A university student living alone (not subject to tax) dependent on parents (subject to tax)

A household in which the parents (not subject to tax) are dependent on a child (subject to tax)

## 2: Items to check and confirm, and necessary documents to enclose

A Confirmation Form or Application Form

- Fill in details of the financial institution account into which the payment is to be made.
- If a proxy (other than the head of the household) is to receive the payment, it is necessary to complete the section on the reverse of the form to give details of the proxy.

### Documents to enclose:

① A document to confirm your identity

✂ A copy of your driving license, a National Health Insurance certificate, a My Number Card (the front), etc.


② A document showing details of the bank account to which the payment will be made

✂ A copy of a bank book, cash card, etc.

③ If the application is made or the payment collected by a proxy: a document to confirm the identity of the proxy.

### Only needed for the applicant:

④ If the applicant moved into Higashihiroshima City on or after January 2nd, 2023, a certificate showing exemption from resident tax, issued by the municipality in which the applicant was living as of January 1st, 2023, is needed.

 **Beware of fraudulent activities related to special one-off payments for households exempt from resident tax, for example requesting payments to be made or asking for your personal information!**

If you receive a suspicious call or suspicious mail at your home or workplace claiming to be from a prefecture, municipality or the national government (or from someone claiming to work for any of these bodies), etc., please contact the municipality where you live, your nearest police station, or the special police advice number (#9110).
