How to Apply For Bank Account Transfer

① Applying at a Financial Institution

Please fill in the provided 'Request for Bank Account Transfer for Municipal Tax' with the necessary information, and submit it at the counter of a financial institution within Higashihiroshima City.

※You will need the stamp/seal (hanko) registered for your bank book.

※Please note that you cannot use Pay-Easy.

② Applying at the City Office (the Tax Collection Division or the National Health Insurance and Pension Division), a Branch Office or Sub-Branch Office

① Normal formalities using the 'Request for Bank Account Transfer for Municipal Tax'

Your registered stamp will need to be checked and confirmed with your bank, and therefore the formalities may take around one month.

② Formalities using the 'Pay-Easy Bank Account Transfer Service'



The formalities are simple: all you need is your cash card (and your PIN number). The time needed for formalities is significantly shortened.

※Please note that you can only use Pay-Easy for Hiroshima Bank, Momiji Bank, Hiroshima Nokyo, and JP Bank accounts.



Your municipal tax helps to support Higashihiroshima City

The municipal tax paid by the citizens of Higashihiroshima City makes up 38.5% of the city's income. Municipal tax enables local government services such as welfare provision, roads, education, garbage disposal, measures against disasters, etc. Please be sure to pay your tax by the payment date.
