Tax Returns for Resident Tax (Municipal and Prefectural Tax)

If you made a tax return for Resident Tax (Municipal and Prefectural Tax) for the 2023-24 financial year, and it is anticipated that you will need to make a tax return for the 2024-25 financial year, you will be sent a tax return form from Higashihiroshima City around the beginning of February. If you don't understand Japanese, please download the foreign language version of the form (in English, Chinese or Vietnamese) from the URL below (or use the QR Code), and use that when making your return.

If you don't understand how to fill in the form, please refer to the content on the website. You may be contacted if the details of your return are unclear, so please be sure to write a telephone number at which you can be contacted.

Final Tax Returns for Income Tax

○ Those who need to make a final tax return: those who have employment income from two or more sources (jobs), and those who have employment income from one source (job), but also a total income of more than 200,000 yen from sources other than employment, etc.

O How to submit the tax return: by e-Tax, or send a printed tax return by post.

Please use the e-Tax system, by which you can make your tax return from home. From the 'Final Tax Return Creation' section of the National Tax Agency's website, if you follow the prompts on the screen, the amount of your tax, etc., will be calculated automatically, and you can create a final tax return form simply and conveniently. The created form can be sent by the e-Tax system, or printed and sent by post, etc.

O Location where you can make final tax returns for income tax: Saijo Tax Office Dates: Friday February 16th to Friday March 15th, from 9:30 to 15:30 (not Saturdays, Sundays or national holidays)

From Monday February 5th to Thursday February 15th (not Saturdays, Sundays or national holidays), consultations on refund declarations will be accepted. An admission number ticket (distributed on the day) will be required.

Admission numbered tickets will be distributed and issued for the date in question. The reception will be closed as soon as the tickets run out.

Alternatively, you can make an online advance reservation, issued by LINE (applications start on Tuesday February 6th)

- * An admission numbered ticket will be required to enter the Tax Office. Depending on the distribution status of admission tickets, you may be asked to visit at a later date.
- * In principle, you will need to prepare the tax return using your own smartphone.
- * If you have n My Number Card, please bring the password for the electronic certificate for user certification of your My Number Card (a 4-digit password), and the password for the electronic certificate for signing (a password of more than 6 alphanumeric characters and no more than 16 characters).

Documents needed for tax returns for resident tax, and for final tax returns for income tax (other documents may also be necessary, depending on your situation

* Please attach these documents to the tax return form if you are filing the return by post, and send them with the form.

- A copy of a document to show your My Number (My Number Card, notification card, etc.); П A copy of a document to confirm your identity (your Residence Card, your My Number Card, etc.); A copy of your bank book (account details) (only for those who are to receive a refund of tax);
- A statement of tax withheld at source (for income, etc.) (not a copy);
- A statement showing the amount of National Health Insurance and National Pension Scheme payments made;
- A statement showing insurance paid (life insurance, earthquake insurance, etc.);
- For students, a copy of your student ID;
- If you are receiving deductions for medical expenses, a statement showing the deductions for medical expenses:
- If you are receiving deductions for donations, a statement showing the amount of donations made. П

You can make tax returns on or after March 16th, but the calculations for your municipal tax, etc., may be delayed, so wherever possible, please submit your tax return within the dates shown above.

Declaration of income for those enrolled in the National Health **Insurance scheme and the Latter Stage Elderly Health Insurance** scheme

Those enrolled in the National Health Insurance Scheme, and those enrolled in the Latter Stage Elderly Health Insurance Scheme, must each make declarations of income, even if they have no income or only income that is not subject to tax.

Even in households with low incomes, If even one member of the household does not make a declaration of income, then no matter how low the income of the household, the members of the household will not be eligible for reductions or exemptions for payments for the National Health Insurance Scheme and the Latter Stage Elderly Health Insurance Scheme. Also, the amount paid by the individual in the case of expensive medical treatment may rise, and the individual may become unable to receive reductions in the cost of food and treatment in medical facilities.

Declaration of income for those enrolled in the National Health Insurance scheme and the Latter Stage Elderly Health Insurance scheme

However, those in the following groups do not need to file a declaration of income.

- Those under the age of 18 (the date for calculation of age for the 2024-25 declaration is January 1st, 2024);
- · Those who have filed a tax return for income tax;
- · Those who have filed a tax return for residence tax;
- Those with only an income from salary, who have made a year-end adjustment at their workplace;
- · Those with only a public pension income (those with only income such as a survivor's pension, disability pension, etc. need to file a declaration)

Th deadline for filing the declaration is Monday April 15th.

Those who are anticipated to need to file a declaration will be sent a declaration form in mid-February.

Those fulfilling all of the following criteria are eligible to apply:

- 1. People who live or work in Higashihiroshima City.
- People who are currently living with a relative, or intending to live with a relative.
- 3. People whose income falls below a certain level.
- 4. People who are not in arrears with municipal taxes.
- 5. People who are currently having trouble with housing.
- 6. People who are not members of criminal gangs.

Please note that it is not possible to keep pets in municipal apartments.

Application forms will be available from the Housing Division, or from branch offices and sub-branch offices from Monday January 29th. Applications will be accepted between Monday February 5th and Friday February 9th, at the Housing Division (Jutaku-ka, 住宅課) (by post or in person). Details of the amount of applications up until the previous day will be made public at the Housing Division and at each of the branch offices.

Extra applications for April 2024 entrance into Misonou Kindergarten are now being accepted. Eligibility is as follows:

New 4-year olds: Children living in Higashihiroshima City, born between April 2nd, 2019 and April 1st, 2020. New 5-year olds: Children living in Higashihiroshima City, born between April 2nd, 2018 and April 1st, 2019.

When applying, please take your child with you to Misonou Kindergarten, and have 1 the application form, 2 an application for eligibility for provision of facility fees, and 3 your certificate of residence (showing all family members). You can obtain 1 and 2 from the Child Care Division or from Misonou Kindergarten. These can also be downloaded from the City website.

It is possible to apply to take a tour of the kindergarten at any time. Contact: Child Care Division (Hoiku-ka, 保育課), tel.: 082-420-0934.

Please pay Fixed Asset Tax and City Planning Tax (the fourth installment) and the National Health Insurance Premium (the eighth installment) by Thursday February 29th. A notice of non-payment (Tokusokujo, 督促状) will be sent to residents who have not paid their tax by the deadline. If you receive a Tokusokujo, please pay the tax immediately, using the payment slip enclosed.

* Note: it takes about ten days for the Tax Collection Division to confirm payment of tax, and therefore you may receive a Tokusokujo even after you have completed payment. In this case, please ignore the letter.

Night-time and holiday hospitals

- Night-time and holiday duty hospitals: Full information about night-time and holiday duty hospitals within Higashihiroshima City is published in the Japanese-language version of the monthly city newsletter 'Higashihiroshima' (the page inside the back cover; only in Japanese), and on the Higashihiroshima City website (in Japanese and English). The information is subject to change at short notice, so before going to a medical facility, please be sure to call to confirm details.
- Recently, there are more and more patients using emergency medical facilities at night and on holidays even though their situation is not serious. In some cases, these patients have prevented or delayed the treatment of patients with truly serious illnesses, and additionally, such cases are one of the reasons for doctors becoming overworked. Emergency medical facilities open at night and on holidays are for patients with serious, emergency conditions. Please try to visit the medical facility you use normally, during opening hours on weekdays.
- Emergency medical treatment for children: Please call the advice line on #8000 (if you cannot get through on this number, please call 082-505-1399). The service is available every day between 19:00 and 8:00 the following morning. You can obtain information about whether or not you should take your child to a medical facility outside of normal opening hours (at nights, on weekends or holidays, etc.).
- If you have a medical problem at night or on weekends, and you are unsure about whether or not you should go to a medical facility: Please call the Hiroshima area emergency consultation center on #7119. The service is free, and is available 24 hours a day, 365 days a year. The staff will be able to give you advice on whether to rest at home and see how symptoms develop, or whether you should go to a medical facility. If necessary, they can give you information about which facility to go to, or they can connect you directly to the 119 emergency service. Please be aware that formalities relating to My Number Cards cannot be dealt with.
