Vaccinations against COVID-19

Currently, the following vaccinations against COVID-19 are available. If you have a vaccination coupon, you can make a reservation and receive the vaccine.

For those aged 12 years of age and over:

• Initial vaccination (first and second doses)

- Vaccination with vaccine effective against the Omicron strain (third to fifth doses)
- For those aged between five and 11 years of age:
- Initial vaccination (first and second doses)
- Booster vaccination (third dose)
- For those aged between six months and four years of age:
- Initial vaccination (first to third doses)

Current vaccinations against COVID-19 will end on Friday March 31st, 2023 (the limit for the current national system).

Certificates of income and tax withheld for 2022 for those with public pensions, etc., will be sent out from the middle of January, from the Japan Pension Service. You will need this document when making a tax declaration for income tax, etc., so please keep it safe.

Please be careful that your water pipes, water meter, etc. don't freeze ・水道管や水道メーターなど の凍結にご注意ください

If you have water pipes or your water meter is outside, on the north-facing side of your accommodation or in a place exposed to the wind, or if the lagging for the pipes or meter is peeling away, wrap the pipes and meter in insulating material, etc., to keep them warm.

If your water pipes burst, shut the telescopic water shut-off valve (the stopcock) inside the meter box, and call a designated water supply works company to request repairs. To ensure that you are prepared for any bursts, check in advance the location of the stopcock, etc. and test to see if the water can be shut off completely.

If you require emergency repairs for a leak inside your house during the year end and new year period (Thursday December 29th - Tuesday January 3rd), please contact the following, between 9:00 and 22:00.

Notice of Medical Expenses for National Health Insurance and Latter Stage Elderly Health Insurance

Twice a year, 'Notices of Medical Expenses' are sent by post. These documents show details of treatments, medical expenses, etc., and checking them contributes to the provision of accurate and appropriate treatment. You do not need to apply to receive these documents. The details are as shown in the table.

These 'Notices of Medical Expenses' can be used when making a detailed list of medical expenses, in order to claim for deductions from income tax, etc., for medical expenses paid.

If you had medical expenses which were eligible to be counted towards deductions, etc., but which were not shown on the notice of medical expenses, please check your receipts from the medical facility, etc., when making the detailed list of medical expenses.

If you have registered to use your My Number Card as a Health Insurance Certificate, you can obtain the information about your Notice of Medical Expenses from the My Number portal site, and use it in the e-Tax system. The data for one year, which you can use in the e-Tax system, will be available from February 9th.

Deadline for payment of taxes: Tuesday January 31st

Please pay Municipal and Prefectural Tax (the fourth installment) and the National Health Insurance Premium (the seventh installment) by Tuesday January 31st. A notice of non-payment (Tokusokujo, 督促状) will be sent to residents who have not paid their tax by the deadline. If you receive a Tokusokujo, please pay the tax immediately, using the payment slip enclosed. * Note: it takes about ten days for the Tax Collection Division to confirm payment of tax, and therefore you may receive a Tokusokujo even after you have completed payment. Night-time and holiday hospitals

• Night-time and holiday duty hospitals: Full information about night-time and holiday duty hospitals within Higashihiroshima City is published in the Japanese language version of the monthly city newsletter 'Higashihiroshima' (the page inside the back cover: only in Japanese), and on the Higashihiroshima City website (in Japanese and English). The information is subject to change at short notice, so before going to a medical facility, please be sure to call to confirm details.

Recently, there are more and more patients using emergency medical facilities at night and on holidays even though their situation is not serious. In some cases, these patients have prevented or delayed the treatment of patients with truly serious illnesses, and

additionally, such cases are one of the reasons for doctors becoming overworked. Emergency medical facilities open at night and on holidays are for patients with serious, emergency conditions. Please try to visit the medical facility you use normally, during opening hours on weekdays.

• Emergency medical treatment for children: Please call the advice line on #8000 (if you cannot get through on this number, please call 082-505-1399). The service is available every day between 19:00 and 8:00 the following morning. You can obtain information about whether or not you should take your child to a medical facility outside of normal opening hours (at nights, on weekends or holidays, etc.).

• If you have a medical problem at night or on weekends, and you are unsure about whether or not you should go to a medical facility: Please call the Hiroshima area emergency consultation center on #7119. The service is free, and is available 24 hours a day, 365 days a year. The staff will be able to give you advice on whether to rest at home and see how symptoms develop, or whether you should go to a medical facility. If necessary, they can give you information about which facility to go to, or they can connect you directly to the 119 emergency service. In an emergency, do not hesitate to phone 119.

Citizens' Affairs Division: Out-of-hours opening

If you have a My Number Card, you can use it to obtain Certificates of Residence, etc., at convenience stores. Please be aware that it is necessary to make a reservation in advance if you wish to be issued with your My Number Card during an out-of-hours opening period. Please also note that matters concerning My Number Cards cannot be dealt with on January 22nd.
