

The system of subsidies for school expenses is a system by which the expenses for school supplies, school meals, etc. are subsidized for the children of parents who need financial support with regard to their child attending school. Eligibility is as follows:

- ✓ A parent/guardian with a child attending a municipal elementary or junior high school in Higashihiroshima City;
- ✓ A parent/guardian living in Higashihiroshima City, with a child attending an elementary or junior high school other than a municipal elementary or junior high school in Higashihiroshima City.
- Documents to submit: Application Form for Subsidies for School Expenses (2024-25 financial year), necessary supporting documents
- Where to submit the documents: The school where your child is enrolled
- X If the child has a sibling enrolled in a different school, the documents should be submitted to each of the schools.
- Application period: At any time (caution: the period of eligibility for subsidies differs depending on the period of application)
- ★ If the application is made by the deadline in April 2024: eligibility for subsidies is from April.
- ★ If the application is made during the school year: as a rule, eligibility for subsidies is from the month after the application is made.

\*\*1 If you have not made a declaration of income, it will not be possible to judge your eligibility, so please ensure that you make a declaration of income. This is necessary even if you have no income.

If you moved into Higashihiroshima City on or after January 2nd, 2024, you will need to submit documents showing the amount of tax you are liable for and the amount of your income, such as a 'Certificate of (Exemption from) Municipal and Prefectural Tax' or a 'Certificate of Income' issued by the municipality where you were living as of January 1st, 2024.

※2 If you are applying under the Reason for Application ®, your application will be judged based on the income of all members of the same household, using the criteria for judging eligibility for welfare support.

\*3 Depending on the status of your household, the Board of Education may request other documents to be submitted.

## 2: Method of payment

Apart from the portion for school meal fees, the payment is made from the City to the applicant via the child's school. As soon as the eligibility to receive subsidies for school meal fees is confirmed, the parent/guardian's payment for school meals by bank account transfer will be stopped.

While the application is being judged, school meals will be payable by bank account transfer by the parent/guardian, but in this case, once eligibility has been confirmed, the payments made until the start of the month in which eligibility begins will be repaid.

## 3: Range of subsidy

The items covered by the subsidy differ depending on the address of the parent/guardian, and on whether or not welfare support (seikatsu hogo) is being received.
